Agencies shall have to submit proper credential having experience in similar nature of work in single tender, as stated in sl no.3 of this NIT, for being entitled to receive tender documents for the work and shall have to satisfy, in addition, the Engineer-in-charge about their capabilities and experience in the type of work involved. Statutory deduction towards labour welfare Cess, GST and I.T. will be as per law in vogue.

Intending tenderers will have to furnish contact no. (Including mobile no.) In their application for any hearing if needed at any point of time. Agencies shall have to produce original documents if required during scrutiny, of application.
