The agency's quoted price shall be inclusive of driver's monthly remuneration as per terms and conditions given in Annexure-1, social and other costs, incidental costs and all local taxes, duties, bonus (if any) etc. but excluding GST which will be paid by HRBC as applicable. The driver proposed to be deputed must be competent enough with experience of not less than 5 (five) years in driving. The period of service can be extended for a period of further 1(one) year with the same terms and conditions and at the same rate of payment, if both the Employer and the Agency agree.

The successful quotationer shall have to submit in the form of a Demand Draft a Performance Security amounting to 2.5% of the Contract Price i.e., 2.5% of the cumulative quoted staff-month price for 12 months and immediately thereafter enter into an agreement on a 100-rupee stamp paper as per the proforma given in Annexure-3 after the issue of Letter of Acceptance (LOA). After the signing of agreement, the Earnest Money submitted by the agency at the time of bidding will be returned. The Performance Securty will be returned after the successful completion of the service period.
