## **NOTICE INVITING QUOTATION**

**Name of Work: Preparation of Report on Model Scheme of Concrete Jetties under Sundarban areas.**

Sealed quotations are invited from reputed firms for providing consultancy services for the above mentioned work. Intending quotationers are to first submit applications with all particulars as mentioned below for consideration of eligibility. Only the applicants considered eligible will be permitted to participate in the tender.

1. Scope of work : (1) The scope of work includes preparation and submission of report on Model Scheme of Concrete Jetties under Sundarban areas with options of different exposure condition.  
(2) The report shall contain - (i) detailed design as per relevant codes, (ii) detailed cost estimate based on current Schedule of Rates for PW(Roads)/PW(NH)/PWD, W.B. including Quantity Calculation & Rate Analysis and (iii) working drawings.
2. Eligibility Criteria : The firm must have experience in the planning and design of bridges/jetties. Authentic documents like Completion/Credential Certificates of similar nature of work executed during the last 10(ten) years shall be submitted.
3. Tender inviting authority : Director (Pl. & Dn.), HRBC
4. Earnest Money : The successful quotationers will have to deposit Earnest Money @ 2% of the total amount of quotation in the form of Bank Draft in favour of "Hooghly River Bridge Commissioners" at the time of execution of formal agreement as per rules.
