## **NOTICE INVITING QUOTATION**

**NIQ NO. HRBC/DYDRPLDN/02 of 2018-2019, Dated: 06.08.2018**

**Name of Work: Planning, design and preparation of drawings of RO RO Steel Structure Gangway at Namkhana in the district of South 24 Parganas.**

Sealed quotations are invited from reputed firms for providing consultancy services for the above mentioned work. Intending quotationers are to first submit applications with all particulars as mentioned below for consideration of eligibility. Only the applicants considered eligible will be permitted to participate in the tender.

1. Scope of work : The scope of work involves planning and detailed design of a 36m. long structural steel gangway including vetting from Jadavpur University/ IEST Shibpur/ any of the IITs as well as preparation of working drawings and detailed cost estimate.
2. Eligibility Criteria : The firm must have experience in the planning and design of steel structures involving bridge/ jetty structure. Authentic documents like Completion/Credential Certificates of such work executed during the last 5(five) years shall be submitted.
3. Tender inviting authority : Deputy Director (Pl. & Dn.), HRBC
4. Earnest Money : The quotationers will have to deposit Earnest Money @ 2% of the quotation in the form of Bank Draft drawn on any Nationalized Bank payable at Kolkata in favour of "Hooghly River Bridge Commissioners".

6. Time of completion : 15(fifteen) days.

Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017.
