Sealed proposals are invited from experienced and reputed Consulting Firms for providing consultancy services for preparation of Detailed Project Report (DPR) in connection with construction of Pontoon Jetty with Pathway, Gangway, Pontoon and other ancillary works Nainan, Falta and at opposite ghat Shibganj, Howrah. Intending bidders are to first submit applications with particulars as mentioned below.

## 1. Outline of Scope of work:

- (i) Preparation and submission of detailed design and working drawings (Good For Construction) as per relevant codes and specifications based on topographical, hydrographic and geotechnical survey data to be supplied by HRBC.
