NOTICE INVITING TENDER

NIT NO. HRBC/DYDRPLDN/01 of 2018-2019, Dated: 31.07.2018

Name of Work: Geotechnical Investigation by making confirmatory boreholes adjacent to the old boreholes made in connection with the construction of flyovers across Kona Expressway at ingress and egress points of Santragachi Bus Terminus.

Sealed tenders are invited from experienced, resourceful and bonafide firms for the above mentioned work. Intending bidders are to first submit applications with all particulars as mentioned below for consideration of eligibility. Only the applicants considered eligible will be permitted to participate in the tender.

1	Scope of work	The scope of work includes geotechnical investigation by making 5 (five) nos. confirmatory boreholes of 30m depth adjacent to old boreholes as indicated in tender drawing and preparation and submission of geotechnical report which shall include, <i>inter alia</i> , calculation of pile capacity of 1000mm dia piles of 25 m length from cutoff level at -2m.
2	Eligibility Criteria	The firm must have experience in carrying out soil investigation work for buildings/bridges etc. Authentic documents like Completion Certificates of such work executed during the last 5(five) years shall be submitted. No permission will be allowed to the firm whose performance in the past is considered unsatisfactory.
3	Tender inviting authority	Deputy Director (Pl. & Dn.), HRBC.
4	Estimated amount put to tender	Rs. 300620/= (exclusive of GST and Labour Welfare Cess)
5	Earnest Money	Rs. 6100/- (Rupees six thousand one hundred only) in the form of Bank Draft drawn on any Nationalized Bank payable at Kolkata in favour of "Hooghly River Bridge Commissioners". Earnest Money of the successful bidder will be converted to Security Deposit and those of the unsuccessful bidders will be released on receiving application for refund after issue of Work Order.
6	Cost of tender documents	Rs. 750/- in cash
7	Time of completion	15 (fifteen) days.
8	Validity of offer	120 Days.
9	Documents to be submitted along with the application	Self attested copies of PAN Card, GSTIN under GST Act, 2017 and documents in respect of eligibility criteria as per Sl.2. Original documents may be produced for verification as per requirements.
10	Last date of application with all particulars at Sl. 9	06.08.2018 within 13.00 hrs.
11	Date of issue of tender documents	07.08.2018 from the Accounts wing of HRBC during office hours.
12	Last date of date and time of submission of tenders	08.08.2018 within 14.00 hrs. in the office of the Dy. Director (Pl. & Dn.), HRBC.

13	Date & time of opening of tenders	08.08.2018 at 15.00 hrs.
14	The bidders are required to quote their rates in percentage above/at par/below the Price Schedule in the specified space of the tender document both in figures as well as in words.	
15	The quoted rate shall include all types of taxes excluding GST and Labour Welfare Cess. GST will be paid/reimbursed by HRBC as per Govt. rules from time to time. Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017.	
16	Security Deposit @ 8% of the value of work will be deducted from the progressive bills.	
17	Statutory deductions towards IT, Labour Welfare Cess etc, as applicable, shall be made from the bills of the contractor.	
18	<p>(i) Additional Performance Security @ 10% of the tendered amount shall be submitted by the successful bidder if the accepted bid value is 80 %/ or less of the estimate put to tender.</p> <p>ii) The Additional Performance Security shall be submitted in the form of Bank Guarantee from any Schedule Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his Earnest Money will be forfeited and other necessary actions as per NIT like blacklisting of the contractor, etc, may be taken. The Bank Guarantee shall have to be valid up to end of the Contract Period and shall be renewed accordingly, if required.</p> <p>iii) The Bank Guarantee shall be returned immediately on successful completion of the Contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor. Necessary provisions regarding deduction of security deposit from progressive bills of the contractor as per relevant clauses of the contract shall in no way be altered /affected by provision of this Additional Performance Security.</p>
