For e-Filling, intending bidder may download the bid document from the e-procurement portal of the Government of West Bengal, viz.; <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a> directly with the help of Digital Signature Certificate. Necessary cost of bid documents (bid fees) shall be furnished through Demand Draft issued from any Nationalized or Scheduled Bank of India in favour of the "HOOGHLY RIVER BRIDGE COMMISSIONERS" payable at KOLKATA and the scanned copy of the same is to be documented through e-filling.

Earnest Money/ Bid Security shall be furnished in the form of Bank Guarantee in favour of the "HOOGHLY RIVER BRIDGE COMMISSIONERS" from any Nationalized or Scheduled Bank of India as per format given in the bid document. Scanned copy of the same is to be documented through e-filling while submitting the bid online.

For online submission, the original hard copies of Bank Guarantee for the Earnest Money Deposit (Bid Security) and Demand Draft for cost of bid document should be deposited to the office of Director (Pl. & Dn.), HRBC physically with application in the letter head of the organisation under sealed cover before technical bid opening as per Time Schedule stated in Sl. No.5 of this NIeB. Bid accepting authority will not be held responsible for late delivery or loss of the Demand Draft/BG in transit. Any bid without such Demand Draft and BG shall be treated as informal and shall automatically stand cancelled.

- 2. The Bid/Proposal is to be submitted in two parts. The two parts of the proposal will be:-
  - (i) Part − 1 : Technical proposal
  - (ii) Part − 2 : Financial proposal
- 3. Bid documents may be downloaded from website and both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed by the bidder through the website *https://wbtenders.gov.in* as per "Date & Time Schedule" as stated in Sl. No.5 of this NIeB.
- 4. Bids shall remain valid for a period of 120 (one hundred and twenty) days after the closing date of Bid submission as specified in S1.5 below.

- 6. Conditional/Incomplete bid will not be accepted under any circumstances.
- 7. The intending bidders are required to quote their rate in the following manner: they shall download the template (Excel sheet) for BOQ, duly fill it up with their offered rate as per Clause 12 of Section A: Instruction to Bidders in the space marked and upload the same duly digitally signed.

- 8. During scrutiny, Tender Inviting Authority (TIA) may verify genuineness of submitted documents and if it comes to the notice of the bid inviting authority that the credential or any other paper found incorrect/constructed /fabricated, that bidder would not be allowed to participate in the bid and that application will be rejected without any prejudice.
- 9. Before issuance of the Letter of Acceptance/Work Order, the bid inviting authority may further verify the credential and other documents of the highest bidder if found necessary. After verification if it is found that the documents submitted by the highest bidder is fabricated or false in that case work order will not be issued in favour of the said bidder under any circumstances.
- 10. HRBC reserves the right to cancel the NIeB or bidding process and also any or all bids at any stage without assigning any reason to the applicant and no claim in this respect will be entertained.
