NOTICE INVITING REQUEST FOR PROPOSAL (NIRFP)

NIRFP NO. HRBC/JET(T)/35 OF 2018-19 dated 27.07.18

Name of Work: Consultancy service in connection with the condition survey of Pontoon cum Gangway jetty no 4 in lot no 8 at Kakdwip on the bank of river Ganga.

Sealed proposals are invited from experienced and reputed Consulting Firms for the above work. Intending bidders are to first submit applications with particulars as mentioned below.

1. Scope of work:

- (i) General visual inspection of the present arrangement and condition of the existing ferry ghats/jetties and making photographic documentation of the same.
- (ii) Making reconnaissance survey and preparing drawing as stands.
- (iii) Physical verification of the dimensions of various elements of existing Jetty No.4 at site shall be done with respect to the drawings supplied by I&W Dte. The adequacy and structure safety of the existing structure shall be examined and supporting design calculation shall be furnished.
- (iv) Bed level profile shown in GA drawing of I&W Dte. and current ADCP survey drawing prepared by I&W Dte. to be studied.
- (v) A new drawing showing improvement scheme by increasing the length of steel gangway from existing 20M. length upto 30M. length, if required, is to be proposed considering the HTL & LTL superimposing current ADCP bed profile, on the bed profile shown in GAD of I&W.
- (vi) For any extension of steel gangway, the design of Yoke supporting platform with foundation and pontoon is to be re-examined for structural safety.
- (vii) Prepare and submit a Condition Survey Report including all the above along with any additional features/information/recommendation as felt necessary and as directed.
- (viii) Necessary integrity test of existing pile and rebound hammer test result will also be studied for preparation of drawing which will be supplied by the office of sr. project Engineer-II

2. Eligibility Criteria:

- i) The firm must have experience in the field of planning and design of bridges/jetties. In support of firm's capability the appropriate and authentic documents like Completion/Credential Certificates of similar nature of work accomplished during the last 10(ten) years have to be submitted along with submission of bid for consideration.
- ii) The firm will submit details of their organization structure, qualification and experience of the resource persons in the field of planning and structural designing relevant to the present job.

Only firms with relevant experience and good track records in the relevant field of work will be considered for being eligible in this particular assignment during evaluation of RFP document.
