GST will be applicable as per GST Act 2017. **Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately that tax charged in accordance with the provisions of GST Act, 2017.** Agencies shall have to submit proper credential having experience in similar nature of work in single tender, as stated in **sl no.3** of this NIT, for being entitled to receive tender documents for the work and shall have to satisfy, in addition, the Engineer-in-charge about their capabilities and experience in the type of work involved. Statutory deduction towards Cess, GST and I.T. as applicable will be made from the bill of the contractor.

Intending tenderers will have to furnish contact no. (**Including mobile number**) In their application for any hearing if needed at any point of time. Agencies shall have to produce original documents if required during scrutiny, of application.
